DATE OF BIRTH \_\_\_\_\_ .FOR THE SUM OF \$ \_\_\_\_\_ .00 DOLLARS. THE BREEDER GUARANTEES THE HEALTH OF THE PUPPY  
AT THE TIME OF PURCHASE.

1. THE BUYER AGREES TO TAKE THE PUPPY TO A VETERARIAN OF THIER CHOOSING WITHIN 4 DAYS OF PURCHASE FOR A HEALTH CHECK.IF THE PUPPY IS FOUND TO BE IN POOR HEALTH , THE BREEDER WILL REIMBURSE THE BUYER THE PRICE OF THE PUPPY UPON THE PUPPYS RETURN TO THE BREEDER, IF DEATH SHOULD OCCUR AN AUTOPSY MUST BE PERFORMED TO DETERMINE THE CAUSE OF DEATH.THE BREEDER WILL PAY THE COST OF THE AUTOPSY AT THIER CHOICE OF VETS. IF IT IS DETERMINED BY THE VET THAT THE DEATH WAS CAUSED BY THE BUYER, THEN THE BUYER WILL REIMBURSE THE SELLER ALL COSTS AND WILL NOT RECIEVE A REFUND ON THE ANIMAL. FAILURE TO COMPLY WITH THIS SECTION WILL AUTOMATICALLY VOID THIS CONTRACT.
2. THE BUYER AGREES TO KEEP THE PUPPIES SHOTS AND WORMING CURRENT AS TO EVERY 3 1/2 WEEKS UNTIL THE PUPPY IS 16 WEEKS OLD, THEN A BOOSTER ONCE A YEAR, AND BE ABLE TO PROVIDE PROOF FROM A VETEINARIAN OF SUCH.
3. THE BREEDER GUARANTEES THE PUPPIES AGAINST HAVING HIP DYSPLASIA UP TO 24 MONTHS OF AGE, AT WHICH TIME THE DOG IS TO BE XRAYED BY AN ORTHROPEDIC VETINARIAN AND THE XRAYS SENT TO THE ORTHROPEDIC FOUNDATION FOR ANIMALS TO HAVE THE HIPS AND ELBOWS CERTIFIED. IF IT IS FOUND THAT THE DOG HAS HIP OR ELBOW DISPLASIA AT THAT TIME , IT IS TO BE RETURNED TO THE BREEDER AND A FULL REFUND FOR THE PURCHASE PRICE IS TO BE GIVEN TO THE BUYER, OR THE PUP WILL BE REPLACED WITH A PUP OF EQUAL VALUE FROM THE NEXT LITTER, IF THE BUYER AGREES TO RELINGUISH THE PUPPY.
4. THE BREEDER RESTRICTS THE BREEDING TO LIMITED WITH AKC, UNLESS THE BREEDING IS PREAPPROVED BY THE BREEDER, AND BOTH THE MALE AND FEMALE HAVE AT LEAST A GOOD RATING FROM THE ORTHROPEDIC FOUNDATION FOR ANIMALS, AND ARE OF EQUAL OR BETTER WORKING STOCK THAN OUR LINES, THIS MUST BE ACCOMPLISHED PRIOR TO THE BREEDING. IF COMPLIED WITH THE BREEDER WILL IMMEDIATELY RELEASE THE BREEDING WITH AKC.
5. THE BUYER AGREES TO KEEP THE DOG IN GOOD HEALTH, WITH REGULAR VET CHECKS, AND THE BUYER GUARANTEES THAT THE DOG WILL NOT BE CHAINED FOR ANY LENGTH OF TIME. AT ANY TIME DURING THE PUPS LIFE, THE BUYER DECIDES NOT TO KEEP THE PUP, IT WILL BE RETURNED TO THE BREEDER.
6. THE SELLER RESERVES AND DEMANDS THE RIGHT TO A REASONABLE INSPECTION OF THE BUYERS PREMISE AT ANYTIME DURING DAYLIGHT HOURS, FOR THE SOLE PURPOSE OF CHECKING THE DOG TO MAKE SURE THE DOG IS BEING PROPERLY CARED FOR, IF IT IS FOUND THAT THE DOG IS NOT BEING CARED FOR WITHIN THAT STATES LAW, THE BREEDER CAN AND WILL CONFISCATE THE DOG AND NO MONIES WILL BE REFUNDED.THE PUPPY IS TO BE SOCIALIZED AND WORKED WITH AT LEAST 2 HOURS A DAY IN A FAMILY SETTING, AND IS TO BE SUBJECTED TO AS MANY DIFFERENT SITUATIONS AS POSSIBLE. THE BUYER AGREES THAT THEY ARE AWARE OF THE HAZARDS OF OWNING A GERMAN SHEPHERD AND AGREE TO NOT HOLD SELLERS LIABLE ON ANY CIVIL ACTIONS.
7. IT IS AGREED BY ALL PARTIES THAT THEY HAVE READ AND UNDERSTOOD THIS CONTRACT AND THAT IT IS A LEGAL AND BINDING CONTRACT BETWEEN THE BREEDER AND THE BUYER (S), IN ANY COURT OF LAW, AND THAT ANY COURT COSTS OR ATTORNEYS FEES REQUIRED TO ENFORCE THIS CONTRACT WILL BE AT THE OFFENDING PARTIES EXPENSE.
